The Irwin County Board of Commissioners had its monthly meeting on August 03, 2020. The meeting was held at the Courthouse in the Courtroom; at the meeting were Chairman Joey Whitley, Commissioner Aldene Tyson, Commissioner Chris Paulk, Commissioner Barron Jones, Commissioner Jimmy Mobley, Attorney Warren Mixon, Octavius Spikes- Road Superintendent, EMA/EMS Director Jerry Edwards, Lee Hunter, Mayor Matt Seale, Chamber Director Cathy Stott, Chief Assessor Hal Roach, Statewide Engineering Mark Dill, Luke Roberts-Reporter and County Clerk Patricia Battle.

The meeting was called to order at 6:00p.m. Commissioner Tyson said the prayer, and everyone pledged the flag.

Commissioner Paulk made a motion to approve the agenda. Commissioner Mobley seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to approve the minutes. Commissioner Paulk seconded the motion. All were in favor. Motion carried.

Commissioner Mobley made a motion to move forward with purchasing equipment to pick up garbage for the county. Truck will cost \$131,500.00, cans \$705.00 each. Commissioner Jones seconded the motion. All were in favor. Motion carried.

Commissioner Mobley made a motion to set the millage rate at 14.868. Commissioner Tyson seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to approve the proposed budget as is and if any changes then it can be done before it is approved. Commissioner Mobley seconded the motion with the exception that it can be changed. All were in favor. Motion carried.

Commissioner Mobley made a motion to accept the bid on Clark Howell Road at \$684,841.04 by Littlefield Construction Company being the only bidder and Meadowlark Road having four bidders; East Coast Asphalt, LLC \$451,629.84, The Scruggs Company \$477,392.49, Reames and Son Construction Company, Inc. \$489,967.20, Reeves Construction Company, Inc. \$489,967.20. The low bidder being East Coast. Commissioner Paulk seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to add Jimmy Mobley to the bank accounts at Irwin County State Bank. Commissioner Jones seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to appoint Jimmy Mobley to the Joint Development Authority board until the end of the year. Commissioner Jones seconded the motion. All were in favor. Motion carried.

Commissioner Jones made a motion to reappoint Karel Mobley to the library board for another three-year term. Commissioner Paulk seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to approve the E&A/E&R Audit report from the Tax Commissioner's office. Commissioner Jones seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to approve a TAN (Tax Anticipation Note) of \$500,000.00 at 1.85% interest from Irwin County State Bank which was the only respondent. Commissioner Paulk seconded the motion. All were in favor. Motion carried.

Commissioner Tyson made a motion to adjourn. Commissioner Paulk seconded the motion. All were in favor. Motion carried.
